**IT IS FURTHER ORDERED that LAURA CARRASCO and ONE  
SERVICE, INC., pay restitution in the amount of \$200.00 to be paid to Jose  
Bustos-Gomez.**

This matter is before the Presiding Disciplinary Judge ("PDJ") on an "Order of Court" issued by the Colorado Supreme Court ("Supreme Court") on January 18, 2012. In its order, the Supreme Court referred this matter to the PDJ for "findings of fact, conclusions of law, and recommendations" pursuant to C.R.C.P. 234(f) and 236(a).

### **I. PROCEDURAL HISTORY**

On December 12, 2011, Kim E. Ikeler, Office of Attorney Regulation Counsel ("the People"), filed a "Petition for Injunction" against Laura G. Carrasco and One Service, Inc. ("Respondents"), alleging they had engaged in the unauthorized practice of law. Respondent Laura Carrasco responded to this petition on January 9, 2012.

The PDJ held an at-issue conference with the parties on February 8, 2012. Mr. Ikeler appeared on behalf of the People, and Ms. Carrasco appeared pro se. Nidia Gomez appeared pro se on behalf of One Services, Inc. The PDJ set various deadlines and scheduled the matter for a one-day hearing to commence on May 21, 2012. On February 27, 2012, the parties filed a "Stipulation, Agreement and Affidavit Consenting to an Order of Injunction."

In the stipulation, Respondents agree to be enjoined from the practice of law. They also agree to pay costs in the amount of \$91.00 within thirty (30) days after the acceptance of the stipulation by the Supreme Court. Respondents further agree to pay restitution to Jose Bustos-Gomez in the amount of \$200.00 and to provide the People with written proof of this payment. Finally,
